Important Notes:

- 1. Registration fee is **not refundable**.
- 2. 2-Day training fee is HK\$ 4,500 for HKPMA member and HK\$ 6,900 for non-member.
- 3. For RTTP training grant application, individual company is encouraged to create system account and apply thru RTTP Online System, and to complete the Autopay application if preferred. Others shall submit a completed RTTP grant application form (Form 2A) to VTC, 2 weeks before course commencement, together with HKID copy of employee nominated for the training and copy of company BR. Late application will not be processed by VTC.
- 4. Each company (HKPMA member) will be entitled to unlimited "Guaranteed" seatings for staff listed as registered AP, and 3 in max. "Reserved" seating for other staff members when seats available.
- 5. For non-member, priority will be given to AP under the category of AP-ATP.
- 6. Physical attendance is required for this 2-day training workshops and the subsequent quiz.
- 7. Testportal (https://www.testportal.net) will be employed for quiz and all learners will receive Testportal invitation emails right before the test/quiz. Note: Testportal is NOT an app and nothing is to be installed in advance.
- 8. COVID-19 RAT self-testing is needed for each training day and evidence must be presented to HKIB when register.
- 9. HKIB reserves all rights to approve or decline any applications based on the above mentioned criteria, unless otherwise justified.
- 10. In case this event is cancelled, participants will be notified as soon as new class is made up.
